This seminar will provide an update on occupational infection risks for dental health-care professionals, as well as a practical discussion of current infection prevention regulations and recommendations for dentistry. The most recent CDC recommendations concerning blood borne pathogens and infection control will be presented, along with updates on OSHA regulations as they pertain to dental settings. Hand hygiene, vaccinations, and other preventive measures (i.e. personal protective equipment, instrument reprocessing, disinfection, and dental water asepsis) are frameworks for this presentation. Blood borne pathogen challenges and prevention strategies will be used to reinforce the application of standard precautions during patient treatment. The most recent evidence-based information is also discussed to address certain issues where perceptions and misuse of infection control procedures and products are in conflict with scientific and clinical knowledge.
